The mission of Vashon Youth and Family Services is to "help Islanders raise thriving, resilient children and youth by fostering a community of emotionally healthy, resourceful families and individuals".

Mental Health & Substance Abuse Services: VYFS is a licensed mental health provider helping children, families and individuals cope with life challenges and stressors through individual and family counseling and therapeutic groups. For over 30 years VYFS has provided local and affordable counseling for island youth, families and individuals. Over 4800 hours of counseling and case management were provided to 314 unduplicated individuals and families. The Holistic Approaches to Recovery Treatment (HART) Program is a State Certified Outpatient Chemical Dependency Treatment Service specializing in youth substance abuse prevention, intervention, assessments, outpatient treatment and aftercare support. Services were provided to 59 individuals and families.

4b (Code:) (Expenses \$ 191,091. including grants of \$) (Revenue \$ 16,446.)

Family Education & Support: This program consists of a collection of activities and services designed to bring parents of pre-school children together to form social support networks and increase parental understanding of children development. Encompassed in this program are the following: (a) play groups for babies, toddlers, and parent/child supervised free play in large PlaySpace area (202 unduplicated participants); (b) parent coaching for 62 parents; (c) parenting classes/groups for pre-birth parents as well as parents of young children and teens (109 participants); (d) supervised visitation for 3 parents; and (e) divorce mediation services for 8 parents.

Childcare: Vashon Kids is a before-and-after school licensed childcare program during the school year and full-time summer childcare program. Services are designed to help children build self-esteem, strengthen positive values and establish healthy behaviors, creating a foundation in which they can grow and develop into healthy, resilient and thriving adults. Financial assistance is available for the fee-based program which served 124 children from 94 families.

Drug-Free Coalition is a collaborative effort with VARSA (Vashon Alliance for the Reduction in Substance Abuse), formerly the Vashon Health Communities Network, to administer Federal grant dollars focusing on reduction of substance abuse among island youth through development of environmental strategies, establishing and strengthening collaboration among community organizations via coalition meetings, surveys, presentations and education.

VIVA/Homeless Program: This emergency and social services program has served Vashon Islanders since 1996, giving support for a variety of basic needs, including vouchers or small grants for shelter, food, utilities, transportation, medications, and other miscellaneous needs for low income families and individuals on Vashon Maury Islands. VIVA staff work closely with other community organizations providing referrals to other community or county resources. One main area of support was helping was helping to find housing for homeless families and individuals. A total of 178 clients, representing 140 families, were provided help through 2408 vouchers in 2012. Drug Free Communities Grant: Through a collaborative effort with Vashon Healthy Communities Network, VYFS administers a federal grant which focuses on reduction of substance abuse among Island youth through development of environmental strategies, establishing and strengthening collaboration among community organizations through coalition meetings, surveys, presentations, and education.
