Mental Health & Substance Abuse Services: VYFS is a licensed mental health provider helping children, families and individuals cope with life challenges and stressors through individual and family counseling and therapeutic groups. For over 30 years VYFS has provided local and affordable counseling for island youth, families and individuals. Over 6,300 hours of counseling and case management were provided to 361 unduplicated individuals and families. The OARS (Outpatient Drug & Alcohol Recovery Services) program is a State-certified outpatient chemical dependency treatment service specializing in youth substance abuse prevention/ intervention, assessments, outpatient treatment and aftercare support, logged over 2100 hours of services to 64 individuals and families.

4b (Code:) (Expenses \$ 244,089, including grants of \$) (Revenue \$ 25,376.)

Family Education and Support: Consists of a collection of activities and services designed to bring parents of pre-school children together to form social support networks and to increase parental understanding of child development. Encompassed in this program are the following: (a) play groups for babies, toddlers, and supervised parent/child free play in large play area (305 unduplicated participants); (b) parent coaching for 80 parents; (c) parenting classes/groups for pre-birth parents as well as parents of young children and teens (123 participants); (d) supervised visitation for 3 parents; and (e) divorce mediation services for 11 parents. Through this program also, wrap-around services were provided to 17 participants and the parent lecture series provided information to 217 parents and care-givers.

Vashon Kids is a before-and-after school licensed childcare program which functions as a full-time childcare program during the summertime. Services are designed to help children build self-esteem, strengthen positive values, and establish healthy behaviors, creating a foundation in which they can grow and develop into healthy resilient and thriving adults. Financial assistance is provided to needy families for this fee-based program which served 126 children from 101 families in 2013.

VIVA/Homeless Program: This program is an emergency basic needs and social services program has served Vashon Islanders since 1996, giving support for a variety of basic needs, including vouchers or assistance for shelter, food, utilities, transportation, medications, and other miscellaneous needs for low income families and individuals on Vashon Island. VIVA staff work closely with other community organizations providing referrals to other community or county resources. One area of support was helping to find housing for homeless families and individuals, and, in collaboration with the Vashon Health Center Volunteers, VIVA helped needy Vashonites with medical expenses. In 2013, a total of 198 (unduplicated) clients, representing 187 families, were served by this program.

Drug Free Communities Grant: Through a collaborative effort with Vashon Healthy Communities Network, VYFS administers a federal grant which focuses on reduction of substance abuse among Island youth through development of environmental strategies, establishing and strengthening collaboration among community organizations through coalition meetings, surveys, presentations, and education.

Drug-Free Coalition is a collaborative effort with VARSA (Vashon Alliance for the Reduction in Substance Abuse), formerly the Vashon Health Communities Network, to administer Federal grant dollars focused on reduction of substance abuse among island youth through development of environmental strategies, establishing and strengthening collaboration among community organizations via coalition meetings, surveys, presentations and education.
